## FINALE v27 SHARING SWEEPSTAKES

## **OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. VOID WHERE PROHIBITED BY LAW.

- 1. **Sweepstakes Entry Period**. The "Sweepstakes Entry Period" begins at 12:00:01 A.M. MT on June 14, 2022 and ends at 11:59:59 P.M. MT on June 28, 2022.
- 2. **Eligibility**. The Finale v27 Sharing Sweepstakes ("Sweepstakes") is open only to legal U.S. residents residing in the United States, or the District of Columbia who are at least: (a) 18 years of age or (b) the age of majority in their state of residence, if higher than 18, at the time of entry, and (c) own a copy of Finale v27 as of the start date of the Sweepstakes Entry Period.
