

FINALE v27 SHARING SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. VOID WHERE PROHIBITED BY LAW.

1. **Sweepstakes Entry Period.** The “Sweepstakes Entry Period” begins at 12:00:01 A.M. MT on June 14, 2022 and ends at 11:59:59 P.M. MT on June 28, 2022.

2. **Eligibility.** The Finale v27 Sharing Sweepstakes (“Sweepstakes”) is open only to legal U.S. residents residing in the United States, or the District of Columbia who are at least: (a) 18 years of age or (b) the age of majority in their state of residence, if higher than 18, at the time of entry, and (c) own a copy of Finale v27 as of the start date of the Sweepstakes Entry Period. Void in Puerto Rico, the U.S. Virgin Islands, U.S. military installations in foreign countries and where prohibited or restricted by law. Employees, officers, directors, members, managers, agents and representatives and their immediate families or members of their household (i.e., spouse, partner, parents, children, siblings, legal guardians, in-laws, grandparents and grandchildren, regardless of where they live) of MakeMusic, Inc. (“Sponsor”) or its partners, affiliates, subsidiaries, parent companies, divisions and advertising, promotion, public relations agencies, are not eligible to enter or win.

Entries using this method must (a) comply with the terms and conditions of these Official Rules, (b) comply with all Finale Terms of Use, and (c) be an original work of composition, and not infringe on the rights of any other person.
- **NO PURCHASE NECESSARY – How to Enter the Sweepstakes by Mail without Payment.** To receive an entry into the Sweepstakes, an eligible person should print your name, e-mail address, phone number and address on a plain 3” x 5” piece of paper. The entry must be mailed in an envelope no larger than #10 (business-size envelope), with sufficient postage affixed, to: MakeMusic, Inc., Attn: Finale v27 Sharing Sweepstakes, 285 Century Place, Louisville, CO 80027. Limit one mailed entry per outer-mailing envelope. All mail-in entries must be postmarked during the Sweepstakes Entry Period. Mail-in entries that are not received by July 1, 2022 will be considered late and will not be accepted.

Only complete and valid entries will be eligible. By entering the Sweepstakes, each entrant warrants that he or she has read and agrees to abide and be bound by these Official Rules and that he or she is not prohibited from participating in the Sweepstakes. Eligible entrants agree that Sponsor shall retain full authority, in its sole discretion, to interpret and administer these Official Rules, and entrants agree to be bound by all decisions and interpretations made in good faith by the Sponsor, or its designee.

All entries become property of Sponsor and will not be acknowledged or returned. Entries that are late, incomplete, garbled/jumbled, illegible, misdirected, lost, damaged, delayed, stolen or otherwise not in compliance with these Official Rules are void. Entries made by any other individual or any entity, and/or originating at any other website or e-mail address, including, without limitation, commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. Sponsor is not responsible for technical failures of any kind, including, but not limited to, electronic malfunctioning of any telephone network, computer hardware or software; any failed, incomplete, garbled or delayed computer transmissions or any combination thereof; or for any error, human, technical or otherwise. Sponsor reserves the right, in its sole discretion, to disqualify any fraudulent entries or any individual it finds tampering with the operation or entry process of the Sweepstakes or acting in violation of these Official Rules. If, for any reason, an entry is determined by Sponsor to have been erroneously deleted, lost or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Sweepstakes, if feasible; if not feasible for any reason, Sponsor shall not have any liability to entrant in conjunction with same.

4. **Intellectual Property.** All intellectual property rights in the original compositions created by entrants in this promotion are retained by the entrant. Sponsor does not take an ownership interest in any compositions submitted for an entry in this Sweepstakes. If Sponsor wishes to obtain a license to use any submitted compositions for marketing purposes, Sponsor will reach out to entrant to negotiate such use, and to prepare and execute a license for such use.

5. **Winner Selection.**

- **Grand Prize Winner Selection.** On or about July 5, 2022, Sponsor will randomly select one entry, from all eligible entries received throughout the Sweepstakes Entry Period, to receive the below defined grand prize (the “Grand Prize”).
- **Second Prize Winner Selection.** On or about July 5, 2022, Sponsor will randomly select three (3) entries from all remaining eligible entries received throughout the Sweepstakes Entry Period, to receive the below defined second prizes (each a “Second Prize”).
- **Third Prize Winner Selection.** On or about July 5, 2022, Sponsor will randomly select five (5) entries from all remaining eligible entries received throughout the Sweepstakes Entry Period, to receive the below defined third prizes (each a “Third Prize”).

Decisions of the Sponsor will be final and binding on all matters relating to this Sweepstakes. If a potential winner does not respond within five business days of the first notification attempt, is found to be ineligible, does not comply with these Official Rules or declines to accept any prize, the potential winner may be disqualified in Sponsor’s sole discretion, and in such case Sponsor may select an alternate winner based on a random drawing.

6. **Prize(s).**

- Grand Prize (1) – The Grand Prize consists of a \$100 gift card to Amazon.com, access to the [Garritan Anthology](#), and a 1-year Performer subscription to [SmartMusic](#). Approximate Retail Value: \$530.00.
- Second Prize (3) – Each Second Prize consists of a \$50 gift card to Amazon.com and access to a Garritan library of second prize winner’s choice. Approximate Retail Value: \$200.00.
- Third Prize (5) – Each Third Prize consists of a \$25 gift card to Amazon.com.

Prizes are not transferable. No substitution or cash redemption of any Prize, or any portion thereof, is allowed, except at the sole discretion of the Sponsor. Sponsor reserves the right to substitute any Prize with another prize of equal or greater value. Sponsor is not responsible for any inability of any winner to accept or use any Prize (or portion thereof) for any reason. No more than the stated Prize(s) will be awarded. Limit of one (1) Prize per family/household/address. Winner is solely responsible for all unspecified costs and expenses associated with Prize acceptance and use. Prizes are awarded “as is” with no warranty, representation or guarantee of any kind by Sponsor. Transfer of Prize is not permitted without the permission of Sponsor which may be granted or withheld in its sole discretion and without liability of any kind. A Prize value as stated represents Sponsor’s good faith determination of approximate retail value of prizes.

7. **Odds of Winning.** Odds of winning each Prize depend upon the total number of eligible entries received during the Sweepstakes Entry Period.

8. **Claiming the Prize.** Each potential winner will be notified by e-mail (if provided) and/or mail or phone. In the event that Sponsor cannot contact a potential winner of any Prize despite reasonable (in its sole discretion) attempts, Sponsor may, in its sole discretion, randomly select a new, alternate potential winner from the remaining eligible entries received. Return of any Prize or prize notification as undeliverable will result in disqualification and an alternate potential winner may be selected in Sponsor’s sole discretion. The potential winner will be required to complete, sign and return to the address requested an Affidavit and Liability/Publicity Release within fourteen (14) days of receipt of the Prize Claim Documents. If such documents are not returned to Sponsor prior to such deadline, any Prize may be forfeited in Sponsor’s sole discretion, such potential winner shall be disqualified, and an alternate winner selected by Sponsor in a new random drawing from the remaining eligible entries. In the event this Sweepstakes is cancelled for any reason, Sponsor reserves the right to conduct a random drawing to award the prizes from among all eligible, non-suspect, entries received prior to the time of the action or event warranting such cancellation.

11. **DISPUTES RESOLUTION.** THIS PROMOTION IS GOVERNED BY THE LAWS OF THE UNITED STATES OF AMERICA AND THE STATE OF COLORADO WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES. As a condition of participating in the Promotion, the entrant agrees that any and all disputes which cannot be resolved between the parties and causes of action arising out of or connected with the Promotion, shall be resolved individually, without resort to any form of class action, exclusively before a court located in Boulder County, Colorado having jurisdiction. Further, in any such dispute, under no circumstances will participant be permitted to obtain awards for, and hereby waives all rights to claim, punitive, incidental, or consequential damages, including reasonable attorneys' fees, other than participant's actual out-of-pocket expenses (i.e., costs associated with entering this Promotion), and participant further waives all rights to have damages multiplied or increased.
